- 2. Curiosity Lab funding authorization** – Brian Johnson, City Manager, provided a breakdown of how the FY24 capital improvement budget for Curiosity Lab will be spent. Project examples included additional video surveillance cameras, expansion of 5G wireless access points, traffic signal cabinet upgrades, and others technology items. This item will be on the agenda at the September 26, 2023 Council meeting.
- 3. Forum Parking Deck Design** - Brian Johnson, City Manager, provided a preview of the final design for the proposed Forum parking deck, a recap of the community engagement activities that NAP organized with adjacent property owners, and a summary of the design modifications undertaken to date. This item will be on the agenda at the September 26, 2023 Council meeting.
- 4. City Logo/Presentation** – Brian Johnson, City Manager, and Keith Curtis with Perkins & Will concluded the yearlong citywide brand assessment with a presentation of two final options for a new city seal/logo. After deliberation, council made its selection.

5. **Pickleball Feasibility Study presentation** – Brian Johnson, City Manager, and Suzy Fisher with Sports Facilities Companies presented the final results from a pickleball feasibility study. Based on the findings, additional analysis will be conducted.
6. **City Marshal vehicle wrap design** – Marshals Henry Mesa and Johnnie Bing presented the new City Marshal uniform and vehicle designs.
7. **City Marshal policies** – David Rhodes, City Attorney, updated the Council on the policy implementation process pertaining to the City Marshal office. Multiple IGAs will be presented at the September 26, 2023 Council meeting.
