

**AN ORDINANCE OF THE CITY OF PEACHTREE CORNERS, GEORGIA, TO AMEND CITY CODE CHAPTER 6, ARTICLE I, IN GENERAL, SEC. 6-1, SALE IN CITY, LICENSE A PRIVILEGE, AND ARTICLE II, RETAIL SALES OF DISTILLED SPIRITS FOR CONSUMPTION ON THE PREMISES, SEC. 6-72, HOURS AND DAYS OF SALE, BY AMENDING PENALTIES FOR VIOLATIONS; REPEALING ALL CONFLICTING ORDINANCES; AND SETTING AN EFFECTIVE DATE**

**WHEREAS**, the sale of alcoholic beverages for on-premises consumption is specifically and clearly regulated; and

**WHEREAS**, in order to ensure that enforcement of these regulations are sufficient to promote compliance, certain amendments to existing regulations are necessary;

**NOW THEREFORE, IT IS HEREBY ORDAINED** by the governing authority of the City of Peachtree Corners, Georgia as follows:

**Section 1:** The City of Peachtree Corners City Code shall be amended by adding (underlined words) and deleting (~~struck through words~~) to Article I, Sec. 6-1, Sale in City; License a Privilege, and Article II, Sec. 6-72, Hours and Days of Sale, as follows:

**ARTICLE I. – IN GENERAL**

**Sec. 6-1. Sale in city; license a privilege; penalties for violations.**

(e) Violations of the provisions of this Chapter shall be subject to citation and prosecution in the City of Peachtree Corners Municipal Court.

**ARTICLE II. - RETAIL SALES OF DISTILLED SPIRITS FOR CONSUMPTION ON THE PREMISES**

**Sec. 6-72. - Hours and days of sale.**

(f) A violation of subsection (a), (b) or (e) of this section as determined pursuant to a hearing as prescribed in Sec. 6-16 by a licensee, majority stockholder, general manager or managing partner of the licensee or licensed establishment shall result in license suspension ~~for a period of two days, which shall be scheduled to include a Friday and Saturday in succession.~~ or revocation. Such suspension or revocation shall be governed by Sec. 6-15.

**Section 2. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.**

**Section 3. This ordinance shall become effective the 28th day of March 2023.**
