REQUEST FOR STREET LIGHTS

The City of Peachtree Corners, GA will coordinate requests for Street Lights with the Georgia Power Corporation. The completed information will be reviewed, and entered into the database for street light tracking. Public Works Staff will conduct a field site investigation and after finalizing all information, a recommendation will be made and an appropriate response will be made to the requesting individual in a timely manner.

Petition for New Street Lights

The Public Works Department will forward the street lighting proposal along with the petition forms to the representative of the homeowners association, its designee or the property owner who initiates the request. A properly executed petition is a generally accepted method to effect a public action. The following rules and requirements, which will be included with the petition forms, help ensure the fairness and integrity of the petition process.

The objective of the City of Peachtree Corners Street Light Petition is to provide homeowners in subdivisions or defined service area without street lights the opportunity to obtain street lights by a method which is fair, equal and favored by a majority of the property owners in the subdivision or defined service area. To have street lights installed by petition process in the City of Peachtree Corners, a petition must be submitted to this office. All of the property owners in the subdivision or defined service area should be contacted and given an opportunity to sign the petition, indicating their “YES” or “NO” concerning the installation of street lights.

If both husband and wife are joint legal owners, both signatures are required. A “Mr. & Mrs.” Signature is not acceptable. All owners must sign individually. This includes owners of undeveloped lots.

Renting tenants are not an acceptable substitute for the homeowner. No signature will be withdrawn from the petition after it is filed with the City of Peachtree Corners.

The purpose of the witness signature is to verify the signatures of the property owners, if in question. The percentages will be calculated, based on individual lots where owners signed in the affirmative, divided by the total number of lots in the plotted subdivision, unit, or “defined service area.” At least 80% of the homeowners must vote in favor of the streetlights before petitions can be presented to the City of Peachtree Corners Council for consideration. **See Appendix B.**

The Completed Petition

The completed petition must be signed, notarized, and returned to the City of Peachtree Corners, where it will be checked against the tax records and land lot maps to insure that it meets all requirements. It will be returned to the sender if it does not meet the requirements.

Petitions that do meet the requirements will be presented to the City of Peachtree Corners Council during their regular scheduled monthly meeting. A public hearing will be announced at that time for each petition. At the public hearing, the petition will be approved or disapproved by the City of Peachtree Corners Council.

The Installation of the Street Lights

Streetlights will be installed by the appropriate utility company and inspected by City of Peachtree Corners Public Works Department. The time frame from receiving the petition to installation of the Street Lights will usually be approximately 12 weeks.

All fixtures and poles shall meet the requirements of the City and all maintenance shall be the responsibility of the power provider.

Installation Costs

Where there are overhead utilities with existing utility poles, there are generally no costs involved to install the lighting fixtures for the property owners. However, lighting installation costs that are required will be passed along to the homeowners prorated over 12 months. All subsequent power costs will also be billed to the homeowners as a line item on their annual Gwinnett County property tax bill.

Utility Companies

Georgia Power is the utility provider of Electric Service to the 22 square miles of Peachtree Corners, GA.
